#### VISTOS:

Las necesidades del Servicio; el Requerimiento N°008/2018 de la Unidad de Investigación, Desarrollo e Innovación; la Ley N°19.886 de Bases sobre Contratos Administrativos de Suministro y Prestación de Servicios; la Resolución Nº1600/2008 de la Contraloría General de la República; el Decreto Supremo M.O.P. Nº 930/1967, que crea el Instituto Nacional de Hidráulica; la Ley N°21.053 de Presupuestos del Sector Público del año 2018; el Decreto Supremo MOP Nº 188/2015, que designa Directora Ejecutiva del INH; la Res. Exenta INH N°342 de fecha 06 de octubre de 2017, que delega facultad para sancionar resoluciones referidas a adquisiciones con tope máximo de 100 UTM; y las atribuciones propias de mi cargo.

#### CONSIDERANDO:

- 1. - agreement.
- Additions, alterations or deviations of or to these Terms or to an agreement between the parties must be in written form signed by the
- If these Terms require a written notice, then this can also include notices in digital form, i.e. per fax or e-mail, unless the context indicates otherwise. The party that chooses to make use of an electronic medium has the burden of proof if the other party states that the electronically communicated statement was not received or not received correctly
- Make Program available
- Deltares makes a Program available to User by sending User the Program including available documentation, a data carrier, or by providing user with a written notice that the Program is available for
- providing user with a written notice that the Program is available for downloading by User.

  Deltares makes available to User the version of the Program that is the most recent at the moment of making the Program available.

  Exceeding a delivery period shall not entitle User to claim damages.

- Licences and intellectual property
  Unless stipulated otherwise in the offer, Deltares grants User a nonexclusive, non-transferable right to use the Program, for an indefinite period of time and against payment of a one-time fee.

  The right of use is limited to User's own use of the Program and to the
- number of agreed users as stipulated in the offer. User is not authorised to grant any sublicences to the Program to third parties, or in any other way to facilitate the use by third parties.
- User does not have the right to modify the Program.

  Except as allowed by applicable law, but in that case limited to the extent required by that law, User may not, and may not authorize any third party to reverse engineer, decompile or disassemble the Program in whole or in part nor create any derivative works from the Program. Deltares is entitled to take technical measures to prevent unauthorized
- Detares is entitled to take technical measures to prevent unauthorized use of the Program. User shall not remove or have removed or circumvent such technical provisions or devices intended for the prevention of unauthorized use of the Program. User acknowledges that the Program is confidential in nature and may contain trade secrets of Deltares. User will keep confidential all information from Deltares of which he may reasonably suspect that it is confidential information and will have disclose such information to third confidential information and will not disclose such information to third parties.

- infringe any third party copyright or any other intellectual property. Any responsibility or liability of Deltares for claims, costs, expenses and/or consequential losses or damages resulting from or arising out of any
